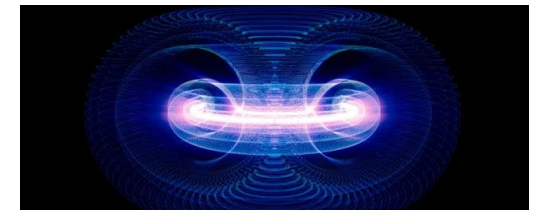

# Environmental Nuclear Council

- Our Environmental Council is a hard working group! As Council Chair for the past year I gained a lot of appreciation for the work they do. Our new Member-at-Large, Hillary Haskins is the new council chair.
- Fusion (E-47) Developed a White Paper and provided feedback and comments to NRC of new technology and rulemaking challenges
- Following Commission votes on proposal for hybrid approach to regulating fusion.
- DOT Exemption E-48: Updated the special permit forms and are developing an accompanying guidance document. The permits, one for radioactivity in scrap and the other for radioactivity in solid waste, are in the process of renewal at DOT.
- Radon E-25 provided comments on the Federal Housing Finance Agency policy on Radon.



# Healing Arts Council

---

- Lisa Bruedigan, our former Treasurer and current Chair-Person, has also been providing leadership oversight to the Healing Arts Council
- H-7 – position statement on the Use of Mobile X-ray units in Lieu of Fixed Units in Urgent Care Clinics – final stages. Two other charges are currently in the works.
- H-11 – Developed and started a new mammography forum – quarterly(ish) call and organized Mammography Training for Houston Annual Conference
- H-32 – Guidance document on remote workstations is ready for peer review
- H-57 – Survey on the impact of the American Board of Radiology no longer providing approval for Authorized Users for RAM licenses
- H-58 – Task Force on Medical Exposure Assessment in the US Population – joint project with NCRP, CDC, FDA, NRC, ACR, AAPM, etc. - developed a survey for the states to identify what dose data is currently collected and what they can potentially provide.
